ORDINANCE NO. 114

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SOUTH INTERNATIONAL FALLS, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND AND UNPLATTED LAND NOT EXCEEDING A TOTAL OF 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS

- WHEREAS: A petition dated July 10, 1973 requesting annexation of the territory hereinafter described was duly presented to the council on that date; and
- WHEREAS: the quantity of land embraced within the area described in the petition and as amended at the public hearing conducted pursuant to said petition, bounded as described, is approximately 44 acres of platted and unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and
- WHEREAS: the petition was signed by a majority but not all of the owners; and
- WHEREAS: no objections to the annexation have been received from the county board and there are no organized townships or abutting municipalities on the land to be annexed; and
- WHEREAS: a hearing was duly held by the governing body of the Village of South International Falls, Minnesota, on the proposed annexation after at least 30 days mailed notice; and
- WHEREAS: the land described in the petition as amended abuts upon the village limits at the West boundary thereof;

The Council of the Village of South International Falls, Minnesota, ordains:

Section 1. The village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the platted and unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

"SE $\frac{1}{4}$  of NE $\frac{1}{4}$  Sec. 4, Twsp. 70, Range 24 lying South and East of the Burlington Northern Railroad right-of-way.

Part of SE $\frac{1}{4}$  of SE $\frac{1}{4}$  Sec. 4, Twsp. 70, Range 24 as follows:  
Auditor's Plat No. 10, Lot 6, Lot 4 and East  $\frac{1}{2}$  of Lots 36, 35, 2 and 1.

East 200 feet of NE $\frac{1}{4}$  of NE $\frac{1}{4}$  Sec. 9, Twsp. 70, Range 24.

Plat of Liberty Addition: That portion of the following blocks lying South and East of the Burlington Northern Railroad right-of-way: Blocks 1, 6 and 7 and all of Blocks 8, 9, 10, 15 and 16, including all abutting streets, avenues and alleys in said plat.

East 200 feet of N $\frac{1}{2}$  of E $\frac{1}{2}$  of N $\frac{1}{2}$  of SE $\frac{1}{4}$  of NE $\frac{1}{4}$  Sec. 9, Twsp. 70, Range 24."

ORDINANCE NO. 114 - Page No. 2

Section 3. Said land shall be included in the commercial industrial district of the village.

Section 4. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the Koochiching County Auditor.

Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
