

ORDINANCE NO. 269

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples does ordain as follows:

Section I.

A petition has been filed with the governing body of the City of Staples, Minnesota, by the owner of the following described tract of real estate to have such tract included within the City of Staples, Minnesota:

Part of the Southeast Quarter (SE $\frac{1}{4}$ ), Section 36, Township 134 North, Range 33 West of the 5th P.M. being more particularly described as follows, to wit: To find the point of beginning commence at the southeast corner of Lot 8, Block 2 of Pine Crest Addition as duly platted and filed; thence S88 $^{\circ}$ 44'30"E 66.0 ft. to a point on the east R/W line of the existing Public Road; thence N00 $^{\circ}$ 14'W and 33.0 ft. east of and parallel with the west line of said SE $\frac{1}{4}$  a distance of 400.0 ft. to the point of beginning; thence from the point of beginning N89 $^{\circ}$ 46'E 400.0 ft.; thence N00 $^{\circ}$ 14'W and parallel with the west line of said SE $\frac{1}{4}$  a distance of 400.0 ft.; thence S89 $^{\circ}$ 46'W 400.0 ft. to a pt. on the east R/W line of the existing Public Road; thence S00 $^{\circ}$ 14'E and 33.0 ft. east of and parallel with the west line of said SE $\frac{1}{4}$  a distance of 400.0 ft. to the pt. of beginning and containing 3.67 acres more or less, together with the east 33.0 feet of the existing Public Road known as 8th Street which abuts the west line of the above premises. Subject to the existing 66.0 ft. easement to the Minnesota Pipe Line Company.

Section II.

The above described land is unplatted and does not exceed 200 acres, and the petitioner, the Christian and Missionary Alliance Church of Staples, is the sole owner of the property.

Section III.

Notice of the filing of the petition has been filed with the Town Board of Thomastown Township, the Wadena County Board of Commissioners, the Minnesota Municipal Commission, and the City Council of the City of Staples at least 60 days prior to the first reading of this ordinance, and that no objections have been received thereto.

Section IV.

All fees required to be paid by the petitioner have been duly paid.

Section V.

The City Council hereby determines that the annexation will be to

the best interests of the City of Staples, Minnesota, and of the territory affected; the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section VI.

Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be and the same are hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section VII.

This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the Town Clerk of Thomastown Township, the Wadena County Auditor, and the Minnesota Secretary of State.
