N ORDINANCE ANNEXING to the City of Roche; ior, Alignosola, Certain Unplatted Land Not exceeding 200 Acres in Area Silvated in Section 15, Township 107 North, Range 14 West, Olmsted County, Minnesota.

THE COMMON COUNCIL OF THE CITY. OF ROCHESTER DO ORDAIN:
Section 1. A petition has been filed with the Common Council of the City of Rochester, signed by a majority of the owners of the land described herein, requesting the Common Council fo annex said land to the City of Rochester. The land described in said petition for annex said in 15 located in Cascade Township Olmsted County, Minnesola, and is described as follows:

That part of the southwest quarter of the southeast quarter of section 15. Township 107 North, Range 14 West of the Fitth Principal Meridian Olmsted County, Minnesola, described as follows:
