

## ORDINANCE NO. 49

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF HILL CITY, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS,

WHEREAS, a certain petition dated August 22, 1973, requesting the annexation of the territory hereinafter described was duly presented to the Council on the 4th day of September, 1973; and

WHEREAS, the quantity of land embraced within the area doscribed in the petition consists of approximately 40 acres of unplatted land, no part of which is included within the limits of an uncorporated city, village or borough; and

WHEREAS, the petition was signed by the sole owner in fee of all of the real property within the area to be annexed; and

WHEREAS, no written objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the existing village limits at and along the south and southwest boundary thereof;

THE COUNCIL OF THE VILLAGE OF HILL CITY, MINNESOTA, ORDAINS: Section 1. The Village Council hereby determines (1) that the annexation will be to the best interests of the municipality and of the territory affected; (2) that the territory described herein abuts upon the existing village limits to the south and southwest and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annoxed. The corporate limits of the Village of Hill City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

That part of the Northwest Quarter of Southwest Quarter  $(NW_{4}^{1} \text{ of } SW_{4}^{1})$  of Section Twenty-four (24), and that part of the Southeast Quarter of Southeast Quarter (SE<sup> $\frac{1}{4}$ </sup>) of SE<sup> $\frac{1}{4}$ </sup>) of Section Twenty-three (23), Township Fifty-two (52), Range Twenty-six (26) which lies West and North of the centerline of County Road No. 82 as said road is now established across said sections.

Section 3. Filing. The Village Clerk is hereby directed to file a copy of this Ordinance with the Minnesola Municipal Committeeton, the Clerk of the Town of Hill Lake, the Aitkin County Auditor and the Minnesota Secretary of State.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the copies thereof as aforesaid.
