



ORDINANCE NO. 603

(M-11)

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation, of the State of Minnesota, to Include Certain Lands Not Exceeding 200 Acres.

Whereas, A petition has been filed with the governing body of the City of Willmar, a Municipal Corporation of the State of Minnesota, by the property owner having the sole interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota, and

Whereas, It is proposed to annex by virtue hereof to said City of Willmar said property, all of which said property is in Kandiyohi County, Minnesota, and

Whereas, The property to be annexed consists of 12.1 acres more or less, described as follows, to-wit:

All that part of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ and the S $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 23, Township 119, Range 35, described as follows: Beginning at the Southwest corner of Pleasant View Addition, as of public record; thence on an assumed bearing of SOUTH, along the West line of the NE $\frac{1}{4}$ of said Section 23, a distance of 1522.90 feet to the Southwest corner of said NE $\frac{1}{4}$; thence on a bearing of S 89° 11' E, along the South line of said NE $\frac{1}{4}$, a distance of 357.09 feet; thence on a bearing of N 47° 21' E, 1395 feet; thence on a bearing of N 42° 10' W, 630.44 feet; thence on a bearing of NORTH, 100 feet to the Southeast corner of said Pleasant View Addition; thence on a bearing of N 89° 04' W, along the South line of said Pleasant View Addition, a distance of 960 feet to the point of beginning.

Now Therefore, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. Best Interests of the City of Willmar and Area to be Annexed. That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the property affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City Limits and is so conditioned as property to be subject to the City Government.

Section 3. Annexation. That the property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had been originally a part thereof.

Section 4. Zoning. The area above described shall be zoned R-2 Residents District.

Section 5. Effective Date. This ordinance shall be filed and shall take effect and be of full force and effect from and after the filing of a copy of this ordinance with the Minnesota Municipal Commission, the Willmar Town Clerk, the Kandiyohi County Auditor, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
