AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF MOOSE LAKE, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND NOT EXCEEDING 200 ACRES 1 AR AREA ABUTTING UPON THE VILLAGE LIMITS

WHEREAS, a certain petition dated April 18th, 1973 requesting annexation of the territory hereinafter described was duly presented to the council on the 7th day of May, 1973.

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 15 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all owners sonstituting all of the owners of the land included in said petition and

WHEREAS, the land described in the petition abutts upon the village limits af the southwest boundary thereof;

The council of the Village of Moose Lake, Minnesota ordains:
SECTION I. The council hereby determines that the annexation will be for the interest of the village and of the territory; that the territory described herein abuts upon the village limits and is urban or suburban in character; and that nomeof said is now included within the limits of any city, village or borough.

SECTION 11. Territory Annexed. The corporate limits of the village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as iff it had originally been a part thereof;

The North Half of the East Half of the North Half of the Northeast Quarter of the Southwest Quarter ( $\mathrm{NI} / 2$ of EI/2 of NI/2 of NEI/4 of SWI/4), of Section Twenty-nine (29), Township Forty-six (46), North of Range Nineteen (19).

The West Half of the North Half of the Northeast Quarter of the Southwest Quarter (WI/2 of NI/2 of NE1/4 of SWI/4) of Section Twenty-nine (29), Township Forty-six (46), Range Ninateen (19).

SECTION III. Filing The Village Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.
