To the 25 May Council:

The Minneapolis & St. Paul Suburban Railroad Company, a corporation organized and existing under the laws of the State of Minnesota, now owning and operating the street railway property within the Village of Excelsior, State of Minnesota, hereby recites that it desires the grant of the grants contained in the following, namely:

An ordinance of the Village of Excelsior, establishing

"An ordinance authorizing The Minneapolis & St. Paul Suburban Railway Company, its successors and assigns, to construct, equip, maintain and operate street railway lines in the Village of Excelsior, Minnesota, and to connect therewith other street railway lines extending from other cities and villages to said Village of Excelsior, and granting to said The Minneapolis & St. Paul Suburban Railway Company, its successors and assigns, certain rights and privileges in relation thereto."

Passed February 21, 1905, as the same has since been amended and now stands, which said grant is now owned by The Minneapolis & St. Paul Suburban Railroad Company;

and any other grant or grants from the Village of Excelsior or any municipality under which acts The Minneapolis & St. Paul Suburban Railroad Company now operates any street railway line or street railway property within said Village of Excelsior, shall become an annexed part under the provisions of Chapter 270, Laws of Minnesota for 1902, (Senate File No. 697), and consents that the terms of said Chapter 270 shall apply to and govern the ownership, control, management, maintenance and operation of the street railway property of said The Minneapolis & St. Paul Suburban Railroad Company.
