ORDINANCE NO. 273

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN.

The City Council of the City of Staples does ordain as follows:

Section I.

A petition has been filed with the governing body of the City of Staples, Minnesota, by the owners of the following described tract of real estate to have such tract included within the City of Staples, Minnesota:

Lots 1, 2, 8, 9, 10, 11 and 12, Block 1; Block 15; Block 16; and Lot 1 of Block 17; all in Vetsch's Addition to Staples, together with all abutting roads, alleys, and streets, located in the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 36, Township 134 North, Range 33 West (Wadena County, Minnesota).

Section II.

The above described land is platted and does not exceed 200 acres, and the petitioners, Derald E. Miller and Juanita Miller, are the sole owners of the property.

Section III.

Notice of the filing of the petition has been filed with the Town Board of Thomastown Township, the Wadena County Board of Commissioners, the Minnesota Municipal Commission, and the City Council of the City of Staples at least 60 days prior to the first reading of this ordinance, and that no objections have been received thereto.

Section IV.

All fees required to be paid by the petitioners have been duly paid.

Section V.

The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota,

and of the territory affected; the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section VI.

Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be and the same are hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.


Section VII.


