Dear Governor Anderson:

As Judge of the District Court in and for the Tenth Judicial District of Minnesota, my term of office expires December 31, 1974. I was born January 18, 1905, and took office as Judge on August 15, 1961. I will not have the required fifteen years to qualify for full pension until August 15, 1976.

Ordinarily, I would be required to file for reelection during the election year of 1974. However, pursuant to the Statutes in the State of Minnesota, I am privileged to forego running for office and request from you an extension of my term until I am qualified for full retirement pay. Therefore, I formally and respectfully request that you issue an order extending my term of office from the expiration of the term in which I was elected to and including August 14, 1976.


WHEREAS, the said Judge Robert B. Gillespie will have reached the age of 70 years on January 18, 1975, and


WHEREAS, M.S. 490.101, Subdivision 4, requires the Governor to make a written order accepting such retirement application and extending such term of office, and

WHEREAS; the necessary legal requirements have been met for such retirement and extension of term,


