ORDINANCE NO. 1973 (1)

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF MAHNOMEN TO INCLUDE CERTAIN PLATTED LANDS HEREIN DESCRIBED AND LOCATED IN THE NORTH-EAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 10, IN PEMBINA TOWNSHIP, MAHNOMEN COUNTY, MINNESOTA

WHEREAS, a certain Petition dated June 13, 1973 was duly presented to the Village Council on the 15th day of June, 1973, copies of said Petition also having been filed with the Town Board of the Township of Pembina and with the County Board of the County of Mahnomen and with the Municipal Commission of Minnesota, which petition was signed by ten of the 19 owners of the territory described therein, and which requested the annexation of said tract to the Village of Mahnomen,

NOW THEREFORE:

The Village Council of Mahnomen, Minnesota does ordain:

Section 1. Declaration. It is hereby determined that the hereinafter described tract is platted land; that said tract abuts on the Southwest boundary of the Village of Mahnomen, and is not presently included within the corporate limits of any incorporated City, Village or Burrough; that no objections to the annexation thereof have been received from the Township of Pembina, Mahnomen County or any other municipality; that said tract is urban in character, and that the annexation therefore would be to the best interest of the Village of Mahnomen and of the said tract.

Section 2. Territory Annexed. The corporate limits of the Village of Mahnomen are hereby extended to include the territory described as follows:

That part of the Northeast Quarter of the Northeast Quarter (NE 1/4 of NE 1/4), Section Ten (10), Township One Hundred Forty Four (144) North, Range Forty Two (42) West described as follows: Beginning at a point 33 feet South of the Northeast corner of said Section 10; thence South on and along the East line of Section 10 a distance of 1287 feet to the South line of the Northeast Quarter of the Northeast Quarter, Section 10; thence deflect right 90 degrees and due west on and along the 1/16 line a distance of 173 feet; thence deflect right 90 degrees and due North and parallel to the East Section line a distance of 1107 feet; thence deflect left 89 degrees and 50 minutes and parallel to the North Section line of said Section 10; a distance of 580.19 feet; thence deflect right 90 degrees and North a distance of 180 feet to the South right of way line of County State Aid Highway No. 5 therebeing; thence East on and along the South right of way line of said Highway No. 5 a distance of

753 feet to the point of beginning, and also a tract described as follows: Beginning at a point on the North line of Section 10, Township 144 North, Range 42 West of the Fifth Principal Meridian, said point of beginning being located 710 feet West of and 33 feet South of the Northeast Corner of said Section 10, thence South 00 minutes, 00 degrees east along a line which is parallel to the east line of said Section 10 a distance of 1290.97 feet; thence South 90 degrees, 00 minutes east perpendicular to the aforementioned line a distance of 537 feet; thence North 00 degrees 00 minutes West along a line which is parallel to the east line of said Section 10 and is the common boundary between Green Acres Subdivisions one and two a distance of 1108.41 feet; thence North 89 degrees, 50 minutes West perpendicular to the last described line a distance of 185 feet; thence North 00 degrees and 00 minutes West parallel to the east line of said Section 10 a distance of 100 feet more or less, to a point of intersection with a line which lies 33 feet south of and parallel to the North line of said Section 10 and is the south right-of-way line of County-State Aid Highway No. 5; thence North 89 degrees 50 minutes West along the last described right of way line a distance of 352 feet, more or less to the point of beginning.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor of Mahanomen County.

Section 4. Effective date. This ordinance shall be in full force and effect from and after the publication and the filing of the certified copies as directed in Section 3, herein.
