



The Minneapolis & St. Paul Suburban Railroad Company, a corporation organized and existing under the laws of the State of Minnesota, now owning and operating certain railway property within the City of St. Paul, State of Minnesota, hereby declares that it decides that each of the grants contained in the following, to-wit:

Ordinance No. 1246 of the City of St. Paul, intitled

"An Ordinance granting permission and authority to the North St. Paul Railway Company to construct, operate and maintain street railway lines from the east end of the cable line on West Seventh Street along certain streets in the City of St. Paul in the direction of North St. Paul"

passed October 11, 1889, approved October 16, 1893, as the same has since been amended and now exists, which said grant is now owned by The Minneapolis & St. Paul Suburban Railroad Company;

and any other grant or grants from the State of Minnesota or the City of St. Paul or any municipality under which The Minneapolis & St. Paul Suburban Railroad Company now operates any street railway line or street railway property within said City of St. Paul, shall become an indeterminate result under the provisions of Chapter 273, Law of Minnesota for 1921 (Senate File No. 607) and consents that the terms of said Chapter 273 shall apply to and govern the ownership, control, management, maintenance and operation of the street railway property of said The Minneapolis and St. Paul Suburban Railroad Company.

Ordinance No. 69 of the City of South St. Paul, entitled "An Ordinance authorizing the Minneapolis and St. Paul Suburban Railway Company, its successors and assigns, to construct, equip, maintain and operate street railway lines in the City of South St. Paul"

passed May 1, 1906, as the same has since been amended and now exists, which said grant is now owned by the Minneapolis & St. Paul Suburban Railroad Company;

and any other grant or grants from the City of South St. Paul or any municipality under which said The Minneapolis & St. Paul Suburban Railroad Company now operates any street railway line or street railway property within said City of South St. Paul, shall become an infeoffment forfeite under the provisions of Chapter 270, Laws of Minnesota for 1921 (Senate File No. 607), and consents that the terms of said Chapter 270 shall apply to and govern the ownership, control, management, maintenance and operation of the street railway property of said The Minneapolis & St. Paul Suburban Railroad Company.
