AN ORDINANCE TO ANNEX TO THE VILLAGE OF MEDFORD, THE FOLLOWING UNINCORPORATED LAND ABUTTING THE VILLAGE OF MEDFORD, COUNTY OF STEELE, STATE OF MINNESOTA, AND DESCRIBED AS FOLLOWS, TO-WIT:

COMMENCING AT A POINT ON THE NORTH LINE OF THE COUNTY STATE AID HIGHWAY #12 AND 13 FEET WEST OF THE WEST END OF WILTON STREET OF MEDFORD VILLAGE; THENCE WEST FOR 80 FEET; THENCE NORTH 1 DEGREE, 35 MINUTES WEST FOR 164.2 FEET; THENCE NORTHEASTERLY FOR 84 FEET ALONG THE SOUTH BANK OF THE STRAIGHT RIVER; THENCE SOUTH 4 DEGREES, 6 MINUTES EAST FOR 216.2 FEET TO THE POINT OF COMMENCEMENT, CONTAINING 0.33 ACRES, ALL BEING IN LOT 8, SECTION 8, TOWNSHIP 108, RANGE 20 WEST, AND LOT 7 IN SECTION 8, TOWNSHIP 108, RANGE 20 WEST.

WHEREAS,

1. Henry Honhouse is the sole owner of the above-described property, containing less than three (3) acres.
2. That the foregoing land is platted.
3. That the said land is abutting the Village limits of the Village of Medford.
