AN ORDINANCE ANNEXING TO THE VILLAGE OF WINSTED, MINNESOTA CERTAIN LAND IN WINSTED TOWNSHIP, BEING A PART OF THE NORTH ONE-HALF OF THE SOUTHWEST ONE-QUARTER (N2-SW4) OF SECTION 11, TOWNSHIP 117 NORTH, RANGE 27 WEST, McLEOD COUNTY, MINNESOTA.

THE VILLAGE COUNCIL OF WINSTED DOES ORDAIN:

Section 1. Winsted Farmers Elevator Company, a corporation organized and existing under the laws of the State of Minnesota is the sole owner of the land hereinafter described, which land abuts upon the present territorial limits of the Village of Winsted; and, as such owner, it has petitioned the Mayor and the Council of the Village of Winsted to annex such land to, and to include within, the Village of Winsted, McLeod County, Minnesota and further to adopt an Ordinance annexing such land to the Village. The tract of land hereinafter described is owned by Petitioner; the South 50 feet comprising approximately 38/100 of an acre is located in Winsted Township, McLeod County, Minnesota and the balance of said described tract of land is presently located in the Village of Winsted, McLeod County, Minnesota; the entire tract of land owned by said Petitioner is described as follows:

That part of the South One-Half of the Northwest One-Quarter (S½-NW½) and of the North One-Half of the Southwest One-Quarter (N½-SW½), Section 11, Township 117 North, Range 27 West, further described as follows:
Beginning at a point in the South line of Baker Avenue (formerly Railroad Street) distant 65 feet Easterly, as measured at right angles, from the West line of First Street, extended Southerly; thence Easterly along said South line of Baker Avenue, a distance of 330 feet; thence South, at right angles to the last described course, to the point 50 feet South of the North line of the North One-Half of the Southwest One-Quarter (N½-SW½) of said Section 11; thence Westerly parallel with said North line to a line drawn at right angles to the aforesaid South line of Baker Avenue from the above described point of beginning.

Section 2. The Mayor and Council of the Village of Winsted do hereby determine that the South 50 feet of the above described tract of land abuts upon the present territorial limits of the Village of Winsted, is urban in character and is so conditioned as to be properly subjected to Village or Municipal Government, and the annexation of said land will be to the best interests of the Village of Winsted and the territory affected.

Section 3. Therefore, the South 50 feet of the foregoing described tract of land is hereby annexed, added to and made a part of the Village of Winsted, Minnesota as effectually as if it had originally been a part thereof.

Section 4. This Ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the McLeod County Auditor, the Town Clerk of Winsted Township and the Secretary of the State of the State of Minnesota.
