ORDINANCE NO. 73-05

AN ORDINANCE ANNEXING TO THE VILLAGE OF WINSTED, MINNESOTA CERTAIN LAND IN WINSTED TOWNSHIP ABUTTING AND LYING WESTERLY OF THE VILLAGE, BEING A PART OF GOVERNMENT LOT ONE (1) OF SECTION THREE (3), TOWNSHIP 117 NORTH, RANGE 27 WEST, McLEOD COUNTY, MINNESOTA.

THE VILLAGE COUNCIL OF WINSTED DOES ORDAIN:

Section 1. All of the owners of certain lands abutting upon the present territorial limits of the Village of Winsted have Petitioned the Mayor and Council of the Village of Winsted to annex such land to, and to include within, the Village of Winsted, McLeod County, Minnesota, and to further adopt an Ordinance annexing said land to the Village. Such land is located in Winsted Township, McLeod County, Minnesota and is described as follows:

That part of U.S. Government Lot One (1), Section 3, Township 117 North, Range 27 West, according to the U. S. Government Survey thereof further described as follows: Commencing at the Southeast corner thereof; thence North along the East line thereof a distance of 835.12 feet; thence West, parallel to the South line thereof, a distance of 208.73 feet; thence South, parallel to the East line thereof, a distance of 835.12 feet; thence East along the South line thereof a distance of 208.73 feet, to the point of beginning, containing 4 acres, more or less.

Section 2. The Mayor and Council of the Village of Winsted do hereby determine that the land described in Section 1. above abuts upon the present territorial limits of the Village of Winsted, is urban in character and is so conditioned as to be properly subjected to Village or Municipal Government, and the annexation of said land will be to the best interests of the Village of Winsted and the territory affected.

Section 3. Therefore, the land described in Section 1. above is hereby annexed, added to and made a part of the Village of Winsted, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This Ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the McLeod County Auditor, the Clerk of Winsted Township, and the Secretary of State of the State of Minnesota.
