ORDINANCE NO. 123

AN ORDINANCE RELATING TO ANNEXATION

The Village Council of Mountain Lake, Minnesota, ordains:

Section 1. Annexed Territory

The following-described territory is hereby annexed to the Village of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:

Tract of land in the Northeast Quarter (NE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$), Section Four (4), Township One Hundred-Five (105) North, (Mountain Lake Township), Range Thirty-Four (34) West of the Fifth Principal Meridian, Cottonwood County, Minnesota, bounded by the following-described lines:

Beginning at a point on the North line of said Section 4, at the Northeast corner of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 4, thence West along the North line of said Section 4, a distance of 952.23 feet; thence South along a line parallel with the East line of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 4, a distance of 183.09 feet; thence East parallel with the North line of said Section 4, a distance of 400.73 feet; thence South parallel with the East line of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 4, a distance of 25 feet; thence East parallel with the North line of said Northwest Quarter (NW $\frac{1}{4}$) of said Section 4, to a point of intersection with the East line of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 4; thence North along the East line of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 4, a distance of 208 feet, more or less, to the place of beginning; excepting therefrom such portion thereof as is presently situated within the corporate limits of the Village of Mountain Lake, Cottonwood County, Minnesota.

Section 2. Effective Date

This Ordinance becomes effective on the date of its publication. Passed by the Village Council, this 4th day of December, 1973,
