ORDINANCE NO. 123

AN OKDINANCE RELATING TO ANNEXATION

The Village Council of Mountain Lake, Minnesota, ordains:

Section 1. Amnexed Territory

The following-described territory is hereby annexed to the Village of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:

Tract of land in the Northeast Quarter (NE%) of the Northwest Quarter (NW1), Section Four (4), Township One Hundred-Five (105) North, (Mountain Lake Pownship), Range of Thirty-Four (34) West of the Fifth Principal Meridian, Cottonwood County, Minnesota, bounded by the following-described lines.
