ORDINANCE NO. 162

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE VILLAGE OF LE ROY, MINNESOTA.

The Village Council of the Village of Le Roy, Mower County, Minnesota, do ordain: 1. WHEREAS, all the owners of the premises hereinaster des-

cribed have petitioned the Village Council that said premises be annexed to the corporate limits of the Village of Le Roy, Minnesota, and said premises being contiguous to and adjoining the Village of Le Roy, and subject to incorporation within the corporate limits of Le Roy, Minnesota, by petition to the governing body of the Village of Le

2. And due notice having been
2. And the notice having been Commissioners of Mower County and the Municipal Commission

of the State of Minnesota; 3. The land hereinafter described shall be added to and incribed shall be added to and in-corporated within the corporate limits of the Village of Le Roy, and said Village Council does hereby declare said premises hereinafter described to be in-corporated within and to be a part of the Village of Le Roy, described as follows:

Beginning at the north 4 corner of Section 34 - T101N - R14W; thence south 846 feet on the west line of the NE1/4 of said section; thence east 344.14 feet at a deflection an-344.14 feet at a deflection angle of 89 degrees, 53 minutes left; thence north 846 feet more or less, on a line parallel with the west line of the NE¼ Section 34 - T101N - R14W to the north line thereof, thence 344.14 feet west on the north line of said 1/4 section, to the point of beginning; being part of the NW¼ NE¼ Section 34 - T101N - R14W, and containing 6.68 acres.

4. This Ordinance shall be in full force and effect from and after its passage and publication.
