

Chapter No. 381

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE  
CITY OF SAUK CENTRE

THE CITY OF SAUK CENTRE DOES ORDAIN:

Section 1. That the following described real property adjoins the City Limits of Sauk Centre and is located in the County of Stearns, State of Minnesota, to-wit:

Outlots 3 and 4 of Sauk Centre Country Club Addition to the City of Sauk Centre, Also Lots 2 through 9 and Outlot A of Golfer's Addition, a subdivision of Government Lot 4 of Section 3 and Government Lot 5 of Section 4, Township 126, Range 34. Also Lots 1 through 9, Block 4, Country Club Addition to the City of Sauk Centre.

Section 2. That more than a majority of the owners of the said land have petitioned the City of Sauk Centre to have the land annexed, added into and made a part of the City of Sauk Centre.

Section 3. That the Town of Sauk Centre has waived any objections to the said annexation, and that a copy of the petition of said annexation has been filed with the Minnesota Municipal Commission.

Section 4. That it will be in the best interest of the said City of Sauk Centre that the said lands be annexed to the said City, and said lands are hereby annexed, taken into, and are hereby made a part of the said City of Sauk Centre in Stearns County, Minnesota.

Section 5. That this Ordinance will take effect and be in force thirty (30) days after its publication.
