

We, the undersigned, residents of sections nine (9), ten (10) fifteen (15) and sixteen (16) of Township Forty-eight (48), Range Twenty-two (22) in Itkin County, Minnesota, do petition the honorable county board of Itkin County, Minnesota, as follows:

Pursuant to adjournment the Board of Commissioners of the County of Aitkin, Minnesota, met at the courthouse in the Village of Aitkin, Minnesota, on the 1st day of June, 1921, the following members being present:

C. A. Maddy, a member of said board offered the following preambles and resolutions and moved their adoption:

WHEREAS A petition has been presented to the board of Commissioners of Aitkin County, Minnesota, petitioning for the calling of an election to determine a proposed incorporation of a village in Aitkin County, to be known as the Village of Tamarack, and

WHEREAS said petition has been approved by said county board of commissioners,

Now, Therefore,

BE IT RESOLVED that said election shall be held on the 30th day of June, 1921, and that a copy of said petition with a notice of election attached thereto, be posted in three public places within the boundaries in said petition described, on or before June 9, 1921; that such notice attached to said petition shall be in substantially the following terms:

NOTICE OF ELECTION TO DETERMINE THE PROPOSED INCORPORATION OF THE VILLAGE OF TAMARACK, MINNESOTA.

Notice is hereby given that an election shall be held in the town hall of the town of Clark, Minnesota, in the proposed village of Tamarack, Minnesota, on the 30th day of June, 1921, for the purpose of voting on the following proposition:

"Shall the territory and lands described in the petition hereto attached be incorporated into a village to be known as the Village of Tamarack".

Poles will be open from 9 A. M. to 7 P. M.
