

That proceedings for annexation relative to the property hereinafter described has been initiated pursuant to the provisions of MSA 414.033 and that all of the provisions of said Statute have been complied with.

That said land is unplatted and the annexation thereof would be to the best interest of the municipality and of the territory affected thereby.
