ORDINANCE NO. 074-5

An Ordinance declaring certain land in Castle Rock Township annexed to the
City of Farmington

THE CITY COUNCIL OF THE CITY OF FARMINGTON ORDAINS AS FOLLOWS:

- Section I That all of the owners of all of the land hereinafter described have petitioned the Vil. Council of the Vil. of Farmington to have said land included within the Vil. of Farmington.
- Section II That since the filing of said petition the Vil. of Farmington has, by operation of law, become the City of Farmington.
- Section III That said land does not exceed 200 acres in area, is territory abutting on the City of Farmington, is not included in any other Village, City or Borough, and is so conditioned as properly to be subjected to the government of the City of Farmington.
- Section IV That it is hereby determined that the annexation of said land to the City of Farmington will be, and is, to the best interests of the City of Farmington and of the territory affected.
- Section V That there is hereby annexed to the City of Farmington all the land lying and being in the County of Dakota and State of Minnesota, described as follows, to-wit

East Seventy-five feet (75') of North one hundred fifty feet (N. 150') of Lot three (3) Alex Empey's Addition to Farmington, according to the recorded plat thereof on file and of record in the office of the Register of Deeds within and for said County and State.

- Section VI That said ordinance shall be in full force and effect from and after its passage and publication and the filing of certified copies with Minnesota Municipal Commission, the Clerk of the Town of Empire, the County Auditor of Dakota County and the Secretary of State of the State of Minnesota, as required by law.

Section VII That section 1-11-2 of the City code is hereby amended to conform to the provisions of this ordinance.
