

ORDINANCE NO. 44

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE VILLAGE OF NEW GERMANY

WHEREAS, a Petition for Annexation has been filed with the Village of New Germany for the annexation of the hereinafter described lands into the corporate limits of the Village of New Germany, and said Petition was signed by all of the owners of the hereinafter described property; and

WHEREAS, More than sixty (60) days have passed since the filing of copies of said Petition with the Carver County Auditor, the Town Clerk of Camden Township, and the Municipal Commission of the State of Minnesota as provided by Minnesota Statutes, Section 414.033; and

WHEREAS, No objection whatsoever to said proposed annexation has been made by any person or party; and

WHEREAS, the Village of New Germany deems that annexation of said property to the Village of New Germany would be in the best interest of the property and of the Village of New Germany;

THE VILLAGE COUNCIL OF THE VILLAGE OF NEW GERMANY, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abuts the present corporate limits of the Village of New Germany; that said lands are unplatted and do not exceed 200 acres in area; that said lands are not now included in any other municipality; that said lands are conditioned as property to be subjected to municipal government; and that annexation of said land would be to the best interest of the Village of New Germany and of the territory to be annexed.

Section 2. Territory Annexed. The corporate limits of the Village of New Germany are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

of A tract of land lying in the Southwest Quarter of Section 4, Township 116 North, Range 26 West, Carver County, Minnesota, described as follows: Beginning at the Northwest corner of Outlot 4 of the plat of New Germany as on file in the office of the Register of Deeds of Carver County, Minnesota dated September, 1915; said point of beginning also being on the centerline of Adams Street extended; thence bearing Easterly and along the North line of said Outlot 4 which is also the South right of way line of the Great Northern Railway distance 1100.0 feet; thence deflecting at an angle to the right of 88° 58' 20" a distance of 441.0 feet which line is also parallel to a line extended Southerly from the point of beginning to the Southwest corner of the Southeast Quarter of the Southwest Quarter of said Section 4; thence deflecting at an angle to the right of 91° 01' 40" and parallel to the said North line of said Outlot 4 distance 1100.00 feet to the said described line extending Southerly from the point of beginning; thence deflecting to the right and extending Northerly along said line a distance of 441.0 feet to the point of beginning; EXCEPTING therefrom that part of said tract which already lies within the corporate limits of the Village of New Germany

Section 3. Filing. The Village Clerk is hereby directed to file copies of this Ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State of Minnesota, the County Auditor of Carver County and the Town Clerk of Camden Township.

Section 4. Effective Date of Annexation. Annexation shall be deemed final upon the filing of copies of this Ordinance as directed in Section 3 above.
