

ORDINANCE NO. 551

AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA WHICH IS BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, the land hereinafter described is not included within the boundaries of any incorporated municipality, and

WHEREAS, sixty percent (60%) or more of the perimeter of this territory is bordered by land already included within the corporate limits of the City of White Bear Lake, and is deemed to be urban in character, and,

WHEREAS, the City Council feels that such annexation will be in the best interest of the City of White Bear Lake and of the affected territory.

NOW, THEREFORE, the Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

The southeast $\frac{1}{4}$ of Section 34-30-22, except the northwest $\frac{1}{4}$ thereof, and except the west 1155 feet of that portion of the southwest $\frac{1}{4}$ of the southeast $\frac{1}{4}$ lying north of the north R/W line of I-694; also, that part of the southeast $\frac{1}{4}$ of the southwest $\frac{1}{4}$ of said Section 34, lying east of the east R/W line of the N. P. Ry.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That this ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after a copy of such is filed with the Minnesota Municipal Commission, Ramsey County Auditor, Secretary of State of the State of Minnesota and the Clerk of the Town of White Bear.
