ORDINANCE NO. 265

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples does ordain as follows:

Section I. The following described tracts of land is owned in its entirety by the City of Staples and abuts on the present city limits line as noted on attached Exhibit "A":

Tract A: The Northeast Quarter of the Southwest Quarter (NEWSWM) of Section 35, Township 134, Range 33 (Wadena County).

Tract B: Lots 2-6, Block 18, Vetsch's Addition to Staples (Wadena County).

Section II. That the quantity of land embraced within the foregoing tracts is as follows:

Tract A: 40 acres

Tract B: 13 acres

Section III. All fees required to be paid have been duly paid,

Section IV. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota, and of the territory affected.

Section V. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be and the same are hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section VI. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Muncipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
