## ORDINANCE NO. 70

## AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE VILLAGE OF HAMBURG

WHEREAS, A Petition for Annexation has been filed with the Village of Hamburg for the annexation of the hereinafter described lands into the corporate limits of the Village of Hamburg, and said Petition was signed by all of the owners of the hereinafter described property; and

WHEREAS, Copies of said Petition have been filed with the Carver County Auditor, Town Clerk of Young America Township and the Municipal Commission of the State of Minnesota, and the Village of Hamburg has complied in all respects with Minnesota Statutes Section 414.033; and

WHEREAS, No objection whatsoever to said proposed annexation has been made by any person or party; and

NHEREAS, The Village of Hamburg deems that annexation of said property to the Village of Hamburg would be in the best interest of the property and of the Village of Hamburg;

THE VILLAGE COUNCIL OF THE VILLAGE OF HAMBURG, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. <u>Declaration</u>. It is hereby determined that the territory described below abuts the present corporate limits of the Village of Hamburg; that said lands are unplatted and do not exceed 200 acres in area; that said lands are not now included in any other municipality; that said lands are conditioned as properly to be subjected to municipal government; and that annexation of said land would be to the best interest of the Village of Hamburg and of the territory to be annexed.

Section 2. <u>Territory Annexed</u>. The corporate limits of the Village of Hamburg are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

All that part of Government Lot 1, Section 28, Townshp 115 North, Range 26 West of the 5th Principal Meridian, described as follows: Beginning at the most Southeasterly corner of Bohlman's Second Addition according to the recorded plat thereof; thence on an assumed bearing of North 33 degrees 19 minutes 05 seconds East along the Southeasterly line of said Bohlman's Second Addition for a distance of 300.00 feet to the most Northeasterly corner of said Bohlman's Second Addition; thence on a bearing of South 89 degrees 56 minutes 00 seconds East for a distance of 176.00 feet; thence on a bearing of South 2 degrees 46 minutes 00 seconds West for a distance of 302.53 feet; thence on a bearing of North 89 degrees 56 minutes 00 seconds West for a distance of 176.00 feet; thence on a bearing of North 71 degrees 04 minutes 30 seconds West for a distance of 158.77 feet to the point of beginning.

Section 3. <u>Filing</u>. The Village Clerk is hereby directed to file copies of this Ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State of Minnesota, the County Auditor of Carver County and the Town Clerk of Young America Township. Section 4. <u>Effective Date of Annexation</u>. Annexation shall be deemed final upon the filing of copies of this Ordinance as directed in Section 3 above.
