AN ORDINANCE ANNEXING CERTAIN UNPLATTED LANDS IN SECTION TEN, TOWNSHIP ONE HUNDRED NINETEEN, RANGE THIRTY FOUR

The Village Council of the Village of Kandiyohi does ordain as follows:

SECTION 1. Origination and Procedure. The Owners of certain unincorporated and unplatted land contiguous to the Village of Kandiyohi petition for annexation pursuant to Section 414.033, Subd. 5 of Minnesota Statutes, which permits the property owners of unplatted lands not exceeding 200 acres to petition the governing body of a municipality to have said land included within said municipality. Such a Petition executed by P. C. Rierson, Margaret I. Rierson, Floyd L. Gimse and Violet L. Gimse dated October 17, 1973, was submitted to the Village Clerk on October 29, 1973, and presented to the Village Council of the Village of Kandiyohi on the 15th day of November, 1973, and thereafter copies of said Petition were filed with the State of Minnesota Municipal Commission, the Kandiyohi Town Board and the Kandiyohi County Board of Commissioners. There being no written objections to the annexation from either the affected Town Board or the Village Council within the time specified, the Village Council thereafter determined that the annexation would be in the best interests of the Village and of the territory affected. This annexation proceedings shall be deemed final upon the filing of a copy of this Ordinance with the State of Minnesota Municipal Commission, the Kandiyohi County Auditor, the Secretary of State for the State of Minnesota and the Kandiyohi Township Clerk.

SECTION 2. <u>Description</u>. The land subject to this annexation is in the County of Kandiyohi, State of Minnesota, and is described as follows, to-wit:

The South 360 feet of the West 950 feet of the Northwest-Quarter of the Northeast Quarter (NW 1/4 of ME 1/4), Section Ten (10), Township One Hundred Nineteen (119), Range Thirty Four (34), except that part platted as Hawkinson's Addition and Lots One and Two (1 and 2) of Plat of Part of the Northwest Quarter of Northeast Quarter (NW 1/4 of NE 1/4) of Section Ten (10), Township One Hundred Nineteen (119), Range Thirty Four (34).

SECTION 3. Annoxation. That the said property is hereby annoxed to, and included within, the Village of Kandiyohi, County of Kandiyohi, State of Minnesota, as effectually as if it had been a part thereof originally.

SECTION 4. Effective Date. This Ordinance is deemed to be in full force and effect from and after its date of publication.
