NOTICE OF INTENTION TO APPLY FOR GOVERNMENT SURVEY OF ISLANDS IN PELICAN LAKE ST. LOUIS COUNTY, MINNESOTA

TO ALL CONCERNED:

You will please take notice that the undersigned, whose post office address is at Virginia, Minnesota, intends to apply to the Commissioner of the General Land office at Washington, D. C. for an official Government survey of the following islands in Pelican Lake, St. Louis county, Minnesota, to-wit:

Those certain fourteen (14) unsurveyed islands located in Townships 64 and 65 North, Ranges 20 and 21 West, Fourth Principal Meridian, St. Louis County, Minnesota, described as follows:

Location and Meander lines of Island No. 1 in Section 4, Township 64 N, Range 20 W., and Section 34, Township 65 N, Range 20 West.

Beginning at Meander Corner No. 22 (South side of Pelican Lake, on section line between Sections 8 and 9, Township 64 N, Range 20 W.) thence N 31°-30' E a distance of 139.50 chains to A. M. C. on West side of island No. 1 whose witness trees are, viz:

Birch 5"-S 36° E-52 links; Birch 7"-N 85° E-28 links. Beginning at a point (A. M. C. Island No. 1), thence N 19° E, a distance of 1 chain to a point, thence N 53°-30' E a distance of 2.50 chains to a point, thence S 56°-30' E a distance of 1 chain to a point, thence S 14°-30' E a distance of 5.75 chains to a point, thence S. 43°-10' W a distance of 1.45 chains to a point, thence N 57° W a distance of 1.25 chains to a point, thence N 32°-30' W a distance of 4.80 chains to the place of beginning (A. M. C. Island No. 1) containing 1.82 acres more or less.

Elm 13"-S 64° W-18 links; Poplar 4"-N 31° E-4½ links. Beginning at a point (A. M. C. Island No. 2), thence N 51° 30' E a distance of 1.15 chains to a point, thence N 3° E, a distance of 1.50 chains to a point, thence S 70°-30' W a distance of 0.70 chains to a point, thence S 53°-15' W a distance of 2.00 chains to a point, thence S 28°-45' E a distance of 1.00 chains to a point, thence S 84°-15' E a distance of 0.80 chains to the place of beginning (A. Beginning at Meander Corner No. 22 (South side of Pelican Lake, on section line between Sections 8 and 9, Township 64 North, Range 20 West), thence N 1°-15' E, a distance of 86.00 chains to A. M. C. on Southeast side of island No. 3 whose witness tree is, viz:

Elm 9"-N 30° W-28 links. Beginning at a point (A. M. C. Island No. 3), thence N 13°-30' W a distance of 1.50 chains to a point, thence N 35°-45' W a distance of 2.00 chains to a point, thence S 67°-45' W a distance of 3.50 chains to a point, thence S 45°-15' E a distance of 2.50 chains to a point, thence S 77°-30' E a distance of 1.74 chains to a point, thence N 72°-30' E a distance of 1.35 chains to the place of beginning (A. M. C. Island No. 3), containing 0.98 acre more or less.

Location and Meander lines of Island No. 4 in Section 5, Township 64 North, Range 20 West.

Beginning at Meander Corner No. 23 (South side of Pelican Lake, on section line between Sections 7 and 8, Township 64 North, Range 20 West, thence N 26°-45' E a distance of 102.00 chains to A. M. C. on the southwest side of Island No. 4, whose witness trees are, viz:

Poplar 3"-N 34° E 22 links; Poplar 4"-N 70° E 22 links. Beginning at a point (A. M. C. Island No. 4) thence N 30° W a distance of 5.70 chains to a point, thence S 84°-30' E a distance of 3.00 chains to a point, thence S 51°-15' E a distance of 2.00 chains to a point, thence S 25° E a distance of 1.50 chains to a point, thence S 11°-45' a distance of 1.00 chain to a point, thence S 26°-30' W a distance of 2.00 chains to a point, thence N 66° W a distance of 1.80 chains to the place of beginning (A. M. C. Island No. 4), containing 1.66 acres more or less.

Location and Meander lines of Island No. 5 in Section 5, Township 64 North Range 20 West.

Beginning at Meander Corner No. 23 (South side of Pelican Lake, on section line between Sections 7 and 8, Township 64 North, Range 20 West) thence N 20° E a distance of 95.10 chains to A. M. C. on southwest side of Island No. 5.

Beginning at Meander Corner on the north side of Bailey's Island said Meander Corner being on small island between Section 6-64-20 and Sec. 1-64-21, 33.51 chains north of Meander Corner No. 26 according to the government plat of Township 64 North, Range 20 W, thence N 50° E a distance of 50.10 chains to A. M. C. on South side of island No. 8, whose witness trees are, viz:

Cedar 7"-N 28° E-14 links; Cedar 7"-North-13 links. Beginning at a point (A. M. C. Island No. 8) thence N 43° W a distance of 0.75 chains to a point, thence N 2° W a distance of 0.65 chains to a point, thence N 77° E a distance of 0.75 chains to a point, thence S 57°-30' E a distance of 2.00 chains to a point, thence S 63° W a distance of 1.00 chain to a point, thence N 80° W a distance of 1.00 chain to the place of beginning (A. M. C. Island No. 8), containing 0.22 acre more or less.

Location and Meander lines of Island No. 9 in Section 32, Township 65 North, Range 20 West.

Beginning at Meander Corner No. 31 (South side of Island between Sections 31 and 32, Township 65, North, Range 20 W), thence S 58° E a distance of 44.30 chains to A. M. C. on the West side of Island No. 9, whose witness tree is, viz:

Norway Pine -5"-N 71° E-28 links. Beginning at a point (A. M. C. Island No. 9), thence N 55° 30' E a distance of 0.50 chains to a point, thence S 76°-15' E a distance of 1.50 chains to a point, thence S 38°-15' E a distance of 0.50 chains to a point, thence S 53° W a distance of 1.00 chain to a point, thence S 84°-30' W a distance of 1.10 chains to a point, thence N 14° W a distance of 1.20 chains to the place of beginning (A. M. C. Island No. 9), containing 0.21 acre more or less.

Location and Meander lines of Island No. 10 in Section 32, Township 65 North, Range 20 West.

Beginning at Meander Corner No. 30 (North side of island between sections 31 and 32, Township 65 North, Range 20 West), thence N 33° E a distance of 5.80 chains to A. M. C. on southwest side of Island No. 10, whose witness trees are, viz:

Cedar 6" N 55° E-22 links; Cedar 6" S 63° E-34 links. Beginning at a point (A. M. C. Island No. 10), thence N 24° W a distance of 2.75 chains to a point, thence N 54° E a distance of 2.25 chains to a point, thence S 37° E a distance of 1.50 chains to a point, thence S 80° E a distance of 4.50 chains to a point, thence S 53° W a distance of 0.40 chains to a point, thence N 42° W a distance of 2.80 chains to the place of beginning (A. M. C. Island No. 10), containing 1.00 acre more or less.

Location and Meander lines of Island No. 11 in Section 32, Township 65 North, Range 20 West.

Beginning at Meander Corner No. 30 (North side of island between sections 31 and 32, Township 65 North, Range 20 West), thence N 82° E a distance of 14.00 chains to A. M. C. on southwest side of island No. 11 whose witness trees are, viz:

White Pine -16"-N 38° E-18 links; White Pine -16"-N 75° E-23 links.

Beginning at a point (A. M. C. Island No. 11), thence N 28° W a distance of 1.70 chains to a point, thence East a distance of 2.70 chains to a point, thence N 47° E a distance of 3.20 chains to a point, thence S 1° W a distance of 1.80 chains to a point, thence S 73°-30' E a distance of 1.95 chains to a point, thence S 32° W a distance of 1.65 chains to a point, thence N 63°-30' W a distance of 1.65 chains to a point, thence S 61° W a distance of 3.15 chains to a point, then N 49° W a distance of 1.30 chains to the place of beginning. (A. M. C. Island No. 11), containing 1.21 acres more or less.

Location and Meander lines of Island No. 12 in Section 31, Township 65 North, Range 20 West and in Section 1, Township 65 North, Range 21 West.

Beginning at Meander Corner No. 2 (West side of point between Sections 30 and 31, Township 65 North, Range 20 West) thence S 33° W a distance of 25.40 chains to A. M. C. on the North side of island No. 12, whose witness trees are, viz:

Birch-4"-S 30° E-20 links; Birch-4"-S 52° E-22 links. Beginning at a point (A. M. C. Island No. 12) thence N 71° E a distance of 2.00 chains to a point, thence S 49° E a distance of 1.50 chains to a point, thence S 8° E a distance of 2.70 chains to a point, thence S 63° W a distance of 2.00 chains to a point, thence N 44° W a distance of 3.60 chains to a point, thence N 32° E a distance of 1.60 chains to place of beginning (A. M. C. Island No. 12), containing 1.23 acres more or less.
