B. The name proposed for said village is "Village of Cooley."

C. No part of the above described territory is in any incorporated city or village. A portion of the territory above described has been platted into lots and blocks by plats which have been duly and legally certified according to the laws of Minnesota, and filed in the office of the Register of Deeds in and for Itasca County, Minnesota. Said territory contains a resident population of not more than three thousand (3000) nor less than two hundred (200) persons. Such part of said territory as is unplatte~~d~~, adjoins the platted portion thereof and is so conditioned as properly to be subject to village government. The quantity of land embraced in the territory above described is 3.038 acres.

WHEREFORE The undersigned respectfully petition the County Board of Itasca County, Minnesota, to call an election for the determination of the proposed incorporation of the Village of Cooley.
