AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MEADOWLANDS TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated September 4, 1973, requesting annexation of the territory hereinafter described was duly presented to the council on the 4 day of September, 1973; and

WHEREAS, The quantity of land embraced within the area described in the petition and bounded as described is one acre of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the northern boundary thereof;

The council of the City of Meadowlands, Minnesota, ordains:

Section 1 The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2 Territory Annexed The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof: That part of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ of NE $\frac{1}{4}$), Section Twenty-two (22), Township Fifty-three (53), Range Nineteen (19), beginning at the Northwest corner of the Northwest Quarter of Northeast Quarter (NW of NW $\frac{1}{4}$ of NE $\frac{1}{4}$), thence south 278 feet, thence east 185.46 feet, thence north 278 feet, thence west 185.46 feet to the point of beginning, St. Louis County, State of Minnesota.

Section 3 Filing The city clerk (recorder) is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4 Effective Date This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

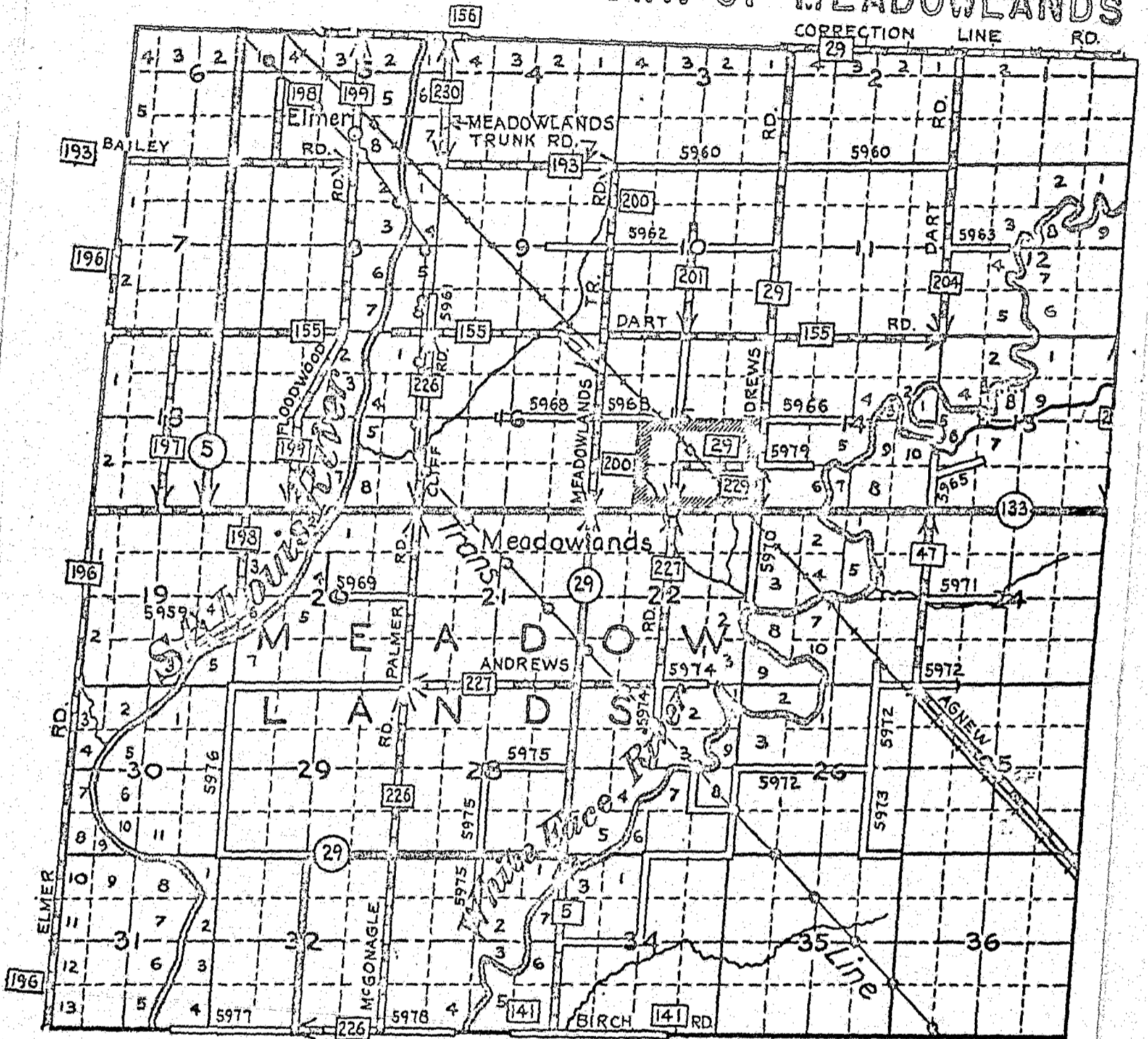
