



EXTRACT OF MINUTES OF MEETING  
OF THE VILLAGE COUNCIL OF THE  
VILLAGE OF MORA, MINNESOTA

Pursuant to due call and notice thereof, a regular meeting of the Village Council of the Village of Mora, Minnesota, was held September 18, 1973, at 7:30 o'clock P.M., in the Council Chambers of the Municipal Building, with the following members present: Mayor Anderson, Councilmen DeWitt, and Kuchar; and the following members absent: Councilmen Harris and Nelson.

3. The Village Attorney presented a proposed ordinance for the annexation of the present village airport. After discussion, member DeWitt introduced the following motion for the adoption of Ordinance No. 110.

ORDINANCE 110

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF MORA TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE VILLAGE OF MORA.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory abutts upon the corporate limits of the Village of Mora at the North and East boundaries thereof and is deemed to be urban in character; and

WHEREAS, the territories are owned in fee by the Village of Mora;

The Village Council of Mora ordains:

Section 1. Territory Annexed. The corporate limits of the Village of Mora are hereby extended to include the unplatted property described as follows now owned by the Village of Mora:
