## ORDINANCE NO. 2.05

AN ORDINANCE ANNEXING CERTAIN UNPLATTED LANDS IN SECTION ONE, TOWNSHIP ONE HUNDRED NINETEEN NORTH, RANGE THIRTY THREE WEST.

The Village Council of the Village of Atwater does ordain as follows:

SECTION 1, <u>Origination and Procedure</u>. The owner of certain unincorporated and unplatted land contiguous to the Village of Atwater petitioned for annexation pursuant to Section 414.033, Subdv. 5, of Minnesota Statutes, which permits a property owner of unplatted land not exceed 200 acres to petition the governing body of a municipality to have said land included within said municipality. Such petition was filed with the Village Council of Atwater on the 6th day of September, 1973, and thereafter copies of said petition were filed with the Minnesota Municipal Commission, the Gennessee Town Board and Kandiyohi County Board of Commissioners. There being no written objections to the annexation from either the affected Town Board or the Village Council within the time specified, the Village Council thereafter determined that the annexation would be in the best interests of the Village and of the territory affected. This annexation proceeding shall be deemed final upon the filing of a copy of this Ordinance with the Minnesota Municipal Commission, the Kandiyohi County Auditor, the Secretary of State for the State of Minnesota, and the Gennessee Town Board Clerk.

SECTION 2. <u>Description</u>. Lands subject to this annexation are in the Township of Gennessee, County of Kandiyohi, State of Minnesota, described as follows, to-wit:

All that part of the North Half of Southwest Quarter (N 1/2 of SW 1/4) of Section One (1), Township One Hundred Nineteen (119), Range Thirty Three (33), described as follows, to-wit: Commencing at the intersection of the centerline of County Road 2, and the Westerly extension of the North line of Lot Six (6), Block Two (2) in Palm's Addition to Atwater; thence along said centerline a distance of 300 feet; thence East and parallel with the North line of Lots Six and Seven (6 and 7) of Block Two (2) In said Palm's Addition a distance of 363 feet; thence South along the centerline extension of Lincoln Avenue as shown on the Plat of said Palm's Addition, a distance of 300 feet to a point on said centerline which intersects the easterly extension of the North line of Lot Seven (7) of Block Two (2) in said Palm's Addition; thence West along the North lot lines of Lots Six and Seven (6 and 7), and the extension of said Lot lines to the point of beginning.

SECTION 3. <u>Annexation</u>. That the said property is hereby annexed to, and included within the Village of Atwater, Minnesota, as effectually as if it had originally been a part hereof.

SECTION 4. Effective Date. This Ordinance is deemed to be in full force and effect from and after its date of publication.
