- 1. REPORTS. The Special Attorney shall submit a monthly report to the Department of Commerce setting forth in detail his activities regarding this appointment for the previous month.
- 2. COMPENSATION AND EXPENSES. As compensation for satisfactory performance of the duties herein described, the Special Attorney shall receive \$10.00 per hour and shall be reimbursed for travel and related expenses in accordance with the rules and regulations promulgated by the State of Minnesota, Commissioner of Administration governing the travel of state officers and employees. In no event shall his hourly compensation and travel expense reimbursement together exceed the amount of \$18,500.00 for the fiscal year ending June 30, 1975. All compensation and expenses shall be paid from funds appropriated to the Department of Commerce.
- 3. STATUS. The Special Attorney shall not be considered a state employee, shall not be eligible for the state's life insurance or basic health benefits coverage and shall not accrue vacation or sick leave or any benefits other than those expressly provided herein.
