Pursuant to the Municipal Commission Order dated June 12, 1974, consolidating the City of Cloquet and the Township of Knife Falls into a single new municipality to be known as the City of Cloquet, and whereby said order retained the Commission's jurisdiction "for the purpose of ordering dates, polling places, the naming of clerks, election judges and any other relevant aspects to the election of officers of the new City" the Minnesota Municipal Commission hereby makes and issues its:

IT IS HEREBY ORDERED THAT:

- 1.) The dates for election of officers shall be:

 October 8, 1974 - General Election

4.) The Acting Clerks shall be John W. Boyer, Cloquet and Isabelle Lindholm, Knife Falls.

5.) The Acting Clerks shall prepare the official election ballot. Affidavits of candidacy may be filed by any person eligible to hold municipal office not more than four weeks nor less than two weeks before the election. At least one week before the first day to file such affidavits the acting clerk shall publish a notice in a newspaper qualified as a medium of official publication and of general publication within the new municipality stating the first and the last dates on which such affidavits may be filed, the location of the clerk's office, the clerk's office hours and the amount of the filing fee.

6.) The acting clerk shall publish a notice of election in a newspaper qualified as a medium of official publication and of general circulation within the new municipality for two successive weeks immediately prior to the election date. The election notice shall state the purpose, date, and polling places for the election, the time the polls shall be open, which time shall be at least five hours.

7.) The election shall be conducted in conformity with the laws for conducting city elections in so far as applicable. Any person eligible to vote at a township or municipal election within the area of the new municipality, is eligible to vote at such election.
