

RESOLUTION NO. 74-5-69

Commissioner Lindgren offered the following resolution:

WHEREAS, the County Board is authorized to establish a Hennepin County License Bureau, pursuant to Chapter 675, Laws of Minnesota, 1973, and Chapter 166, Laws of Minnesota, 1974, and since the District Court Administrator is in favor of removing the non-court related activity of licensing from his responsibility,

BE IT RESOLVED, that a Hennepin County License Bureau be established effective July 1, 1974 pursuant to Laws of the Sate of Minnesota and,

BE IT FURTHER RESOLVED, that the Director of Finance and Records be appointed the Director of the Hennepin County License Bureau and Deputy Registrar of Motor Vehicles and that he perform all the duties, functions and responsibilities required by Chapter 675, Laws of Minnesota, 1973 and Chapter 166, Laws of Minnesota, 1974, and,

BE IT FURTHER RESOLVED, that the License Division of the District Court including appropriate personnel, office equipment and budget is hereby transferred to the Department of Finance and Records and the Director of Finance and Records is authorized to organize this function within the department as he deems appropriate, consistent with efficient and convenient service to the public and,

BE IT FURTHER RESOLVED, that the County Administrator be authorized to initiate all necessary budget adjustments and accounting entries to transfer the licensing function from District Court to the Department of Finance and Records.
