

ORDINANCE NO. 1974-C

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ST. JOSEPH TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND BELONGING TO THE CITY OF ST. JOSEPH AND ADJACENT TO THE CORPORATE LIMITS THEREOF.

WHEREAS, the territory described below is not presently included within the corporate limits of any incorporated City, Village or Borough; and

WHEREAS, this territory belongs to the City of St. Joseph and is deemed to be urban character.

NOW THEREFORE, the City Council of the City of St. Joseph, Minnesota, ordains:


Section 1. Territory Annexed. The corporate limits of the City of St. Joseph, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory belongs to the City of St. Joseph, and is urban in character.


All that part of the East Half of the Northeast Quarter (E $\frac{1}{2}$ NE $\frac{1}{4}$ ) of Section Nine (9), and of the West Half of the Northeast Quarter (W $\frac{1}{2}$ NE $\frac{1}{4}$ ) of Section Ten (10), all of Township One Hundred Twenty Four (124) North of Range Twenty Nine (29), West, Stearns County, Minnesota, described as follows: Beginning on the North line of U.S. Trunk Highway No. 52, as the same is now located, at the point of its intersection with the West line of Schneider's Addition to the Village of St. Joseph; thence Northerly along the West line of Schneider's Addition a distance of Eight Hundred (800) feet; thence due West a distance of Eight Hundred (800) feet; thence due South to the North line of U.S. Trunk Highway No. 52; thence Easterly along the North line of U.S. Trunk Highway No. 52 to the point of beginning.

Section 2. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Secretary of State, The County Auditor, the Register of Deeds of the County in which the property is located, the Minnesota Municipal Commission and the Township Clerk of the Township of St. Joseph.


Section 3. Effective Date of Annexation. This Ordinance takes effect upon the passage and publication and the filing of certified copies as directed in Section 2.
