Ordinance No. 1974-D

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ST. JOSEPH TO INCLUDE CERTAIN PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council on the 21st day of March, 1974; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 1.55 acres of platted land, no part of which is included within the limits of any incorporated city, village or borough, and

WHEREAS, the petition was signed by all of the owners of said tract; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the City limits of the City of St. Joseph at the Northerly boundary thereof;

NOW THEREFORE, the City Council of the City of St. Joseph, Minnesota, ordains:

Section 1. The City Council determines:

- a. That the annexation would be to the best interest of the City and the territory affected;
- b. That the territory described therein abuts upon the City limits and is about to become urban or sub-urban in character;
- c. That none of said territory is now included within the limits of any City, Village or Borough.

Section 2. The corporate limits of the City are hereby extended to include the platted lands described as follows and the same is hereby annexed to and included within the City as effectively as if it had originally been a part thereof;

Lots Three (3), Four (4), Five (5), Six (6), Seven (7), Eight (8), Nine (9) and that part of Ten (10) lying outside of the limits of the City of St. Joseph, all being part of Schneider's Addition.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor, the Register of Deeds, and the Township Clerk of the Township of St. Joseph.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
