

ORDINANCE NO. 1258

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND ABUTTING THE CITY OF AUSTIN LIMITS.

WHEREAS, a certain petition dated March 27, 1974, requesting annexation of the territory described herein was duly presented to the Common Council on the 15th day of April, 1974, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 1.04 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the petition was signed by all of the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipalities whose boundaries abutt upon the land to be annexed.

WHEREAS, the land described hereinafter abuts the city limits on the North boundary thereof.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The City Council hereby determines that the annexation will be in the best interest of the City and of the territory affected. That the territory described herein abutts the City limits and is urban or suburban in character and that none of the said territory is now included within the limits of any city, village or borough,

SECTION 2: The corporate limits of the City of Austin are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

North 90' of the South 211 ft. of that part of the north $\frac{1}{4}$ of the West $\frac{1}{4}$ of the Southwest quarter of the Northwest quarter of Section 10, Township 102N, Range 15W lying and being West of the Center line of Turtle Creek (this also includes a 33' by 90' Highway easement on T.H. 105)

SECTION 3: The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Austin Township Clerk, the County Auditor, Register of Deeds, Austin Utilities and Secretary of State.

SECTION 4: This ordinance takes effect upon its passage and publication and filing of these certified copies as directed in Section 3.
