AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE INCORPORATED LIMITS OF THE CITY OF WATERTOWN, MINNESOTA

THE CITY COUNCIL OF THE CITY OF WATERTOWN, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. That pursuant to Minnesota Statutes 414.033, the City Council of the City of Watertown having determined that those certain lands as hereinafter set forth are completely surrounded by land within the municipal limits of the City (formerly designated Village) of Watertown and not included in any other municipality and conditioned as properly to be subjected to municipal government, the corporate limits of the City of Watertown are hereby extended to encompass and embrace all that certain land described as follows, to-wit:

That part of Outlots/56, 57 and 58 according to the original plat of the Townsite of Watertown on file and of record in the office of the Register of Deeds, Carver County, Minnesota, described as follows:

Beginning at the most Westerly corner of Outlot 58; thence in a Northeasterly direction along the Northwesterly line of said Outlot 58 for a distance of 198.00 feet; thence in a Southeasterly direction parallel to the Southwesterly line of said Outlot 58 for a distance of 196.50 feet, more or less, to a point; thence in a Northeasterly direction, parallel to the Northwesterly line of said Outlots 56, 57 and 58 a distance of 260.00 feet, more or less, to a point on the Northeasterly line of said Outlot 57; thence continuing in a Northeasterly direction a distance of 152.00 feet 8 inches to a point 200.00 feet Northwesterly of the Southeasterly line of Outlot 56 as measured parallel to the Northeasterly line of Said Outlot 56; thence Southeasterly parallel with the Northeasterly line of said Outlot 56, 200.00 feet to a point 152.00 feet 8 inches from the Southeasterly corner of said Outlot 56; thence Southwesterly along the Southeasterly line of said Outlot 56; thence Southwesterly along the Southeasterly line of said Outlot 56, 57 and 58 to the Southeasterly line of said Outlot 58; thence Northwesterly along the Southwesterly line of said Outlot 58; thence Northwesterly along the Southwesterly line of said Outlot 58; thence Northwesterly along the Southwesterly line of said Outlot 58; thence Northwesterly along the Southwesterly line of said Outlot 58; thence Northwesterly along the Southwesterly line of said Outlot 58; thence Northwesterly along the Southwesterly line of said Outlot 58 to the point of beginning.

Commencing at the Southeasterly corner of Outlot 55; thence running in a Northeasterly direction along the Southeasterly line of said Outlot 55 a distance of 132.00 feet; thence Northwesterly, parallel with the Southwesterly line of said Outlot 55, a distance of 165.00 feet; thence Southwesterly on a line parallel to the Southeasterly line of said Outlot 55 a distance of 132.00 feet to the Southwesterly line of said Outlot 55; thence Southeasterly along the Southwesterly line of said Outlot 55; thence of 165.00 feet to the place of beginning. Also, all that part of deferson Street lying between the Northeasterly line of White Street and the Southeasterly extension of the Northeasterly line of Outlot 55.

and said land is by this Ordinance declared annexed to the City of Watertown. Section 2. The City Clerk is hereby directed to file certified copies of


