ORDINANCE NO. 558 <sup>A-2599</sup> <sub>White Bear Lake</sub> APR 22 1974

AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA, WHICH IS BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, the land hereafter described is not included within the boundaries of any incorporated municipality, and

WHEREAS, sixty (60%) percent or more of the perimeter of this territory is bordered by land already included in the corporate limits of the City of White Bear Lake, and is deemed to be urban in character, and

WHEREAS, the City Council feels that such annexation will be in the best interests of the City of White Bear Lake and of the affected territory.

NOW, THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain:

- 1. The following described land situated in Ramsey County, Minnesota, to-wit:

Except that portion already annexed by the City of White Bear Lake, that portion of the southeast 1/4 of Section 27-30-22 lying east of the west right of way line of the Northern Pacific Railroad (said west right of way line being the east corporate limits of the Village of Gem Lake); subject to highway and street rights of way; and that portion of the northeast 1/4 of Section 27-30-22 lying east of the west right of way line of the Northern Pacific Railroad, subject to highway and street rights of way; and that portion of the east 1/2 of the southeast 1/4 of Section 22-30-22 lying east and southeast of the west right of way line of the Northern Pacific Railroad subject to street rights of way and that portion of the northwest 1/4 of the southwest 1/4 of Section 23-30-22 lying southeasterly of the centerline of Hoffman Road subject to street rights of way.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

- 2. That this ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after a copy of such is filed by the City Clerk with the Minnesota Municipal Commission, the Ramsey County Auditor, the Secretary of State of the State of Minnesota, and the Clerk of the Town of White Bear.
