

ORDINANCE NO. 116

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF NORWOOD TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated May 15, 1973, requesting annexation of the territory hereinafter described was duly presented to the council on the 18th day of May, 1973; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 52.67 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by seven owners, constituting a majority but not all of a total number of eleven owners; and

WHEREAS, no objections to the annexation have been received from the town board, county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was duly held by the governing body of the Village of Norwood, Minnesota, on the proposed annexation after at least 30 days mailed notice; and

WHEREAS, the land described in the petition abuts upon the Village limits at the North boundary thereof; the council of the Village of Norwood, Minnesota, ordains:

Section 1. The Village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The

corporate limits of the village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

That part of the Northwest Quarter of Section 14, Township 115 North, Range 26 West, Carver County, Minnesota, described as follows:

Beginning at the Southwest corner of the Northwest Quarter of the Northwest Quarter of said Section 14; thence on an assumed bearing of North 1 degree 00 minutes 04 seconds East along the West line of said Northwest Quarter of the Northwest Quarter for a distance of 1329.02 feet to the Northwest corner of said Northwest Quarter; thence on a bearing of East along the North line of said Northwest Quarter for a distance of 2030.50 feet to the Northeast corner of said Northwest Quarter; thence on a bearing of South 39 degrees 33 minutes 37 seconds West for a distance of 334.65 feet to the centerline of Old Trunk Highway No. 5 and 25; thence on a bearing of South 56 degrees 26 minutes 08 seconds West along the centerline of said Old Trunk Highway No. 5 and 25 for a distance of 1014.73 feet; thence on a bearing of South 33 degrees 33 minutes 32 seconds East for a distance of 33.00 feet to the Southeasterly right of way line of said Old Trunk Highway No. 5 and 25; thence on a bearing of South 56 degrees 26 minutes 08 seconds West along said Southeasterly right of way line of Old Trunk Highway No. 5 and 25 for a distance of 737.60 feet; thence on a bearing of North 33 degrees 33 minutes 52 seconds West for a distance of 191.00 feet; thence on a bearing of South 36 degrees 26 minutes 03 seconds West for a distance of 240.00 feet; thence on a bearing of South 27 degrees 57 minutes 35 seconds West for a distance of 119.20 feet to the South line of said Northwest Quarter of Northwest Quarter; thence on a bearing of South 89 degrees 29 minutes 03 seconds West along said South line of the Northwest Quarter of the Northwest Quarter for a distance of 536.70 feet to the actual point of beginning. This tract contains 52.67 acres of land and is subject to the following roadway easements: Old Trunk Highway No. 5 and 25, New Trunk Highway No. 5 and 25, County State Aid Highway No. 33, and Trunk Highway #212.

Section 3. Filing. The village clerk is

hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance

takes effect upon its passage and publication and the filing of the certified
