## AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE CITY OF WACONIA

WHEREAS, the Common Council of the City of Waconia has determined that certain lands in the Town of Waconia are completely surrounded by the present corporate limits of the City of Waconia, and that said lands are urban in character; and

WHEREAS, Minnesota Statutes, Section 414.033, Subd. 4, provides that such lands may be annexed by Ordinance without notice:

THE COMMON COUNCIL OF THE CITY OF WACONIA, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. <u>Declaration</u>. It is hereby determined that the territory described below is completely surrounded by the present corporate limits of the City of Waconia; that said lands are not now included in any other municipality; that said alnds are conditioned as properly to be sugject to municipal government; and that annexation of said lands would be in the best interests of the City of Waconia and of the territory to be annexed.

Section 2. <u>Territory Annexed</u>. The corporate limits of the City of Waconia are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

A. That part of Government Lot 3, Section 13, Township 116 North, Range 25 West, described as follows:
