The Minnesota Municipal Commission received a petition by the land-owners for the detachment of land from the City of Ogilvie, Minnesota on the 13th day of May, 1974. A resolution for the detachment of the same land was received from the City of Ogilvie on the 13th day of May, 1974.

The territory involved consists of the following:

Begin 245.2 feet North of Southeast corner NW SW  
thence West 333 feet thence North and parallel with  
East line 335.6', thence East parallel with South  
line 3 feet, thence North and parallel with East  
line to the North line of said 40, the East on said  
40 line to the N.E. corner of said 40, thence South  
on said East line to the point of beginning.

The property is located adjacent to the Township of Kanabec, Kanabec County and said lands are unplatted and used for agricultural purposes. The petition is in proper legal form and sets forth the information required in Minnesota Statutes 414.06 and upon the files and records, the Minnesota Municipal Commission hereby issues its Order.


IT IS HEREBY ORDERED: That the foregoing described real property be, and the same hereby is, detached from the City of Ogilvie and made a part of the Township of Kanabec, Kanabec County, Minnesota, the same as if it had originally been made a part thereof.

IT IS FURTHER ORDERED: That the population of the City of Ogilvie, be and the same hereby is decreased by twelve (12) for all purposes until the next federal census.

IT IS FURTHER ORDERED: That the population of the Township of Kanabec be and the same hereby is increased by twelve (12) for all purposes until the next federal census.


