ORDINANCE NO. 1230

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY OWNED BY THE CITY OF AUSTIN AND ADJACENT THEREON.

WHEREAS, the territory described below is not presently included within the corporate limits of any City, Village or Borough, and

WHEREAS, the City of Austin is the owner of the land described below and said premises adjoin the City of Austin and is deemed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1: The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows:

All that part of the SE^{1/4} of Section 36, Township 103 North, Range 18 West, Mower County, Minnesota lying North of the main channel of Dobbins Creek and North of the North branch of said Dobbins Creek as it proceeds in a general Northeastly and Southwesterly direction except the following described parcel.

Beginning 1514.94 feet North of the Southwest corner of the Southeast $\frac{1}{4}$ of said Section 36 on the West Line of said $\frac{1}{4}$ section; thence East 280 feet; thence South 270.31 feet; thence South $73^{\circ}23'$ West a distance of 153.03 feet; thence North $66^{\circ}08'$ West a distance of 146.80 feet to a point on the West Line of said $\frac{1}{4}$ section; thence North on said $\frac{1}{4}$ line a distance of 258.20 feet to the point of beginning.

SECTION 2: The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, and the Township Clerk of Lansing Township in which the property is located, and the Minnesota Municipal Commission.

SECTION 3: This ordinance takes effect upon passage and publication and filing certified copies as directed in Section 2.
