

Ordinance No. A-73-103

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES ABUTTING UPON THE CITY LIMITS

WHEREAS, the City of Mankato has acquired property abutting the corporate limits of the City of Mankato: and

WHEREAS, the quantity of the land embraced within the area described in the petition does not exceed 200 acres, and abuts upon the City Limits at the easterly boundary thereof, no part of which is included within the limits of an incorporated city, village, or borough; and

THE CITY OF MANKATO, MINNESOTA, DOES ORDAIN:

. That the annexation will be to the best interests of the City and of the land affected;

2. That the land described herein abuts upon the City Limits and is urban in character; and

3. That none of said land is now included within the limits of any city, village, or borough.

The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:
