ORDINANCE NUMBER A-74-108

AN ORDINANCE TO AMEND AN ORDINANCE KNOWN AS CHAPTER  
13, UNCODED ORDINANCES IN EFFECT OF THE CITY CODE OF  
THE CITY OF MANKATO, MINNESOTA

WHEREAS, certain territory described below is not presently  
included within the corporate limits of any incorporated city, village  
or borough; and,

WHEREAS, this territory, 60% or more of which is bordered  
by lands already included within the corporate limits of the City,  
does not exceed 200 acres; and,

WHEREAS, no objections to the annexation have been received  
from the Town Board, the County Board or the governing body of any  
municipality whose boundaries abut upon the boundaries of the land  
to be annexed;

THE CITY OF MANKATO, MINNESOTA DOES ORDAIN:

1. That the annexation will be to the best interests of the City  
and of the land affected;
2. That the land described herein abuts upon the City limits and  
is urban in character; and
3. That none of said land is now included within the limits of  
any city, village or borough.

The corporate limits of the City are hereby extended to include  
the unplatted land described as follows and the same is hereby  
annexed to and included within the City as effectually as if it had  
originally been part thereof:

All that land in the Northeast Quarter and the North-  
west Quarter of Section 1, Township 108 North, Range  
26 West, Government Lots 6 and 7, lying Easterly of  
the centerline of Trunk Highway 169 and Westerly of  
the centerline of the Minnesota River.

The City Clerk is hereby directed to file certified copies of the  
Ordinance with the Minnesota Municipal Commission, the Secretary of  
State and the Nicollet County Auditor. This Ordinance shall take  
effect thirty days (30) after the date of its passage and publication.
