A map was enclosed with each filing showing the location of the land parcel to be annexed. I indicated that it was the intent of the City Council to begin annexation action on June 6, 1974.


No objection to this annexation has been received from any of the governmental agencies so notified. I did receive a letter of "No Objection" from the Pipestone County Board of Commissioners.

ORDINANCE NO. 1.41

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY
TO THE CITY OF PIPESTONE

THE COUNCIL OF THE CITY OF PIPESTONE, DO ORDAIN AS FOLLOWS:

Section 1. The land described as follows, to-wit:

All that part of the West Half of the Southeast
Quarter of Section 18, Township 106 North, Range
45, West of the 5th P.M. and lying West of the
East line of Highway 75, Pipestone County,
Minnesota, consisting of 30 acres more or less,
not now in the City of Pipestone,

is hereby declared to be a part of the City of Pipestone, Minnesota.

Section 2. This ordinance shall take effect and be in full force
from and after its passage and publication.
