

WHEREAS, this territory is owned in fee by the city;

The city council of Annandale ordains:

Section I. Territory Annexed. The corporate limits of the city of Annandale are hereby extended to include the unplatted property described as follows now owned by the city: The South Half of the Northeast Quarter of Section 29, Township 121, Range 27 except: (1) The East 450 feet and South 170 feet of the Southeast Quarter of the Northeast Quarter; (2) An area 250 feet North and South and 500 feet East and West in the Northwest corner of the Southwest Quarter of the Northeast Quarter.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the town clerk of the town in which the property is located, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.
