ORDINANCE NO. 73-7
AN ORDINANCE CONCERNING ANNEXATION

THE CITY OF GRANITE FALLS DO ORDAIN AS FOLLOWS:

The City of Granite Falls being the sole owner of the real estate described in this Ordinance, which real estate is unincorporated land abutting the City of Granite Falls declares that the following described real estate situated in Chippewa County, State of Minnesota, is annexed to the City of Granite Falls, State of Minnesota,

The Northerly 660.0 feet of the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirty-Five (35), Township One Hundred Sixteen (116) North, Range Thirty-Nine (39) West, County of Chippewa, containing 40.0 acres, more or less, and

A parcel of land in the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirty-Five (35), Township One Hundred Sixteen (116) North, Range Thirty-Nine (39) West, County of Chippewa, described as follows:

Beginning at a point on the West line of said Southeast Quarter (SE $\frac{1}{4}$) a distance of 660.0 feet South of the Northwest corner of said Southeast Quarter (SE $\frac{1}{4}$); thence Easterly parallel to the North line of said SE $\frac{1}{4}$ a distance of 660.0 feet; thence Southerly parallel to the West line of said SE $\frac{1}{4}$ a distance of 710.0 feet, more or less, to the center line of Chippewa County Highway No. 38 as now laid out and maintained in said SE $\frac{1}{4}$, thence Northwesterly along the center line of said Highway No. 38 a distance of 675.0 feet, more or less, to the West line of said SE $\frac{1}{4}$; thence North along the West line of said SE $\frac{1}{4}$ a distance of 515.0 feet, more or less, to the point of beginning, containing 9.31 acres, more or less, and

The Northerly 660.0 feet of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Thirty-Six (36), Township One Hundred Sixteen (116) North, Range Thirty-Nine (39), West, County of Chippewa, containing 20.0 acres, more or less.
