

WHEREAS, the City became the owner of the real estate described below, and

WHEREAS, said real estate is to be devoted to park purposes and it is therefore desirable that it be annexed to the City of Morris.

NOW THEREFORE, THE CITY OF MORRIS DOETH ORDAIN:

That the following described real estate situated and located in the County of Stevens, State of Minnesota, to-wit:

PARCEL 1

A parcel of land in the southwest quarter (SW $\frac{1}{4}$), Section 31, Township 125 North, Range 41 West, Stevens County, Minnesota, more particularly described as follows: Beginning at the southwest corner of said Section 31; thence north along the west line of said Section 31 to the northwest corner of the southwest quarter (SW $\frac{1}{4}$) of said section 31; thence east along the east and west one quarter line of said Section 31, 660 feet; thence south and parallel to the west line of said section 31 to the south line of said section 31; thence west along said south line of section 31 to the place of beginning, excepting therefrom the right-of-way of the public road in the northwest corner of the southwest quarter (SW $\frac{1}{4}$) of said section 31. Containing 39.49 acres, more or less.

PARCEL 2

A parcel of land in the east half of the southeast quarter (E $\frac{1}{2}$ SE $\frac{1}{4}$) Section 36, Township 125 North, Range 42 West, more particularly described as follows: Beginning at the southeast corner of said Section 36; thence north along the east line of said Section 36 to the northeast corner of the southeast quarter (SE $\frac{1}{4}$) of said Section 36; thence west along the east and west one quarter line of said Section 36, 660 feet; thence south and parallel with the east line of said section 36 to the south line of said Section 36; thence east along the south line of said section 36, 660 feet to the point of beginning, excepting therefrom the public road right of way in the northeast corner of the southeast quarter (SE $\frac{1}{4}$) of said section 36. Containing 38.55 acres, more or less.

PARCEL 3

The southeast quarter of the southwest quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 1, Township 124 North, Range 42 West, Stevens County, Minnesota, excepting therefrom the public road right of way along the south line of said Section 1. Containing 39.00 acres, more or less.

PARCEL 4

A parcel of land in the southwest quarter of the southwest quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 1, Township 124 North, Range 42 West, Stevens County, Minnesota, more particularly described as follows: Beginning at the northeast corner of the southwest quarter of the southwest quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$) of said section 1; thence south along the east line of said southwest quarter of the southwest quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$), 815 feet, more or less; thence in a northwesterly

direction to a point on the north line of said southwest quarter of the southwest quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$), said point being 200 feet, more or less, east of the west line of said Section 1; thence east along said north line of said southwest quarter of the southwest quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$), 1125 feet, more or less, to the point of beginning. Containing 10.53 acres, more or less.

PARCEL 5

A parcel of land in the east half of the northwest quarter (E $\frac{1}{2}$ NW $\frac{1}{4}$) and in the north half of the southwest quarter (N $\frac{1}{2}$ SW $\frac{1}{4}$), Section 1, Township 124 North, Range 42 West, Stevens County, Minnesota, more particularly described as follows: Beginning at the north quarter corner of said Section 1; thence south along the north and south quarter line of said Section 1 to the southeast corner of the northeast quarter of the southwest quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$) of said Section 1; thence west along the south line of the north half of the southwest quarter (N $\frac{1}{2}$ SW $\frac{1}{4}$) of said Section 1, to the west line of said Section 1; thence north along the west line of said Section 1 to the northwest corner of the southwest quarter (SW $\frac{1}{4}$) of said Section 1; thence east along the east and west quarter line of said Section 1, to a point 660 feet west of the northeast corner of the southwest quarter (SW $\frac{1}{4}$) of said Section 1; thence north and parallel to the north and south quarter line of said Section 1 to the north line of said Section 1; thence east along the north line of said Section 1, 660 feet to the point of beginning. Containing 117.10 acres, more or less.

PARCEL 6

A parcel of land in the east half (E $\frac{1}{2}$) of Section 1, Township 124 North, Range 42 West, Stevens County, Minnesota, more particularly described as follows: Beginning at the southwest corner of the southeast quarter (SE $\frac{1}{4}$), Section 1, Township 124 North, Range 42 West; thence north along the north and south one-quarter line of said section 1 to the north one-quarter corner of said section 1; thence east along the north line of said section 1, 1000 feet; thence south and parallel with the north and south one-quarter line of said section 1, 3810 feet, more or less, to a point; thence in a southwesterly direction to the point of beginning. Containing 102.43 acres, more or less.

PARCEL 7

That fractional part of the northeast quarter of the northwest quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$), Section 12, Township 124 North, Range 42 West, Stevens County, Minnesota, more particularly described as follows: Beginning at the northeast corner of said northeast quarter of the northwest quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of said section 12; thence south along the quarter section line of said section 12, 500 feet, more or less; thence south seventy-four degrees and 40 minutes (74⁰40') west, 752 feet, more or less; thence north twenty-four degrees and no minutes (24⁰00') west, 330 feet, more or less; thence north nineteen degrees and five minutes (19⁰05') west, 436 feet, more or less, to the north line of said section 12; thence east along said north line of said section 12, 1000 feet, more or less, to the point of beginning; excepting therefrom the right of way of the Public Highway along said north line of said section 12 as shown on the Supplementary Land Acquisition Map, Pomme de Terre Storage Project Number 9, Works Progress Administration, Emergency Relief Administration, State Department of Conservation, State of Minnesota, approved by Walter S. Olson. Containing 11.56 acres, more or less.

PARCEL 8

That fractional part of the northeast quarter of the northwest quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 12, Township 124 North, Range 42 West, Stevens County, Minnesota, more particularly described as follows: Beginning at a point on the north line of said section 12 that is 1000 feet west of the north quarter corner of said section 12; thence south nineteen degrees and five minutes (19 $^{\circ}$ 05') east 436 feet; thence south twenty-four degrees and no minutes (24 $^{\circ}$ 00') east 330 feet; thence in a northwesterly direction and in a straight line 578 feet, more or less, to a point that is 500 feet south and 1260 feet west of said north quarter corner of said section 12; thence north 500 feet, more or less, to the north line of said section 12; thence east along said north line of said section 12, 260 feet, more or less, to the point of beginning, excepting therefrom the right of way of the public highway. Containing 4.85 acres, more or less, which parcels are collectively known as POMME DE TERRE STATE PARK.


