ORDINANCE NO. 353

AN ORDINANCE DECLARING CERTAIN CITY PROPERTY ANNEXED TO CITY.

WHEREAS, the City of Morris is the owner of the real estate described below, and

WHEREAS, Minnesota Statutes, Chapter 414.033 grants power to the City Council to declare municipally owned, abutting land annexed to the City, and

WHEREAS, the Planning Commission of said city, after due consideration, has recommended that said real estate be annexed to the city.

NOW, THEREFORE, THE CITY OF MORRIS DOETH ORDAIN:

That the following described real estate situated and located in the County of Stevens, State of Minnesota, be and hereby is annexed and caused to be a part of the City of Morris, Minnesota, to wit:

A tract of land located in the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) of Section 2, Township 124 North, Range 42 West, more particularly described as follows:

Beginning at a point 1344.47 feet East of the center of said Section 2. Thence East along the North line of the NE 1/4 of the SE 1/4 of said Section 2 a distance of 1187.50 feet more or less to the East section line of said Section 2. Thence South and along the East section line of said Section 2 a distance of 997.5 feet. Thence proceeding Northwesterly a distance of 978 feet to a point 247.5 feet South of the North boundary of the NE 1/4 of the SE 1/4 of said Section 2 and 630 feet West of the Eastern section line of said Section 2. Thence West and parallel with the North boundary of the NE 1/4 of the SE 1/4 of said Section 2 a distance of 557.50 feet more or less to the Northeast corner of the Elles addition to the City of Morris. Thence proceeding North a distance of 247.5 feet to the point of beginning, containing 12.17 acres more or less.
